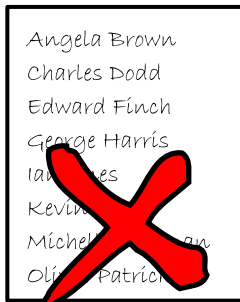
All dentists and dental workers need to be on one of our lists to be allowed to work in the United Kingdom.

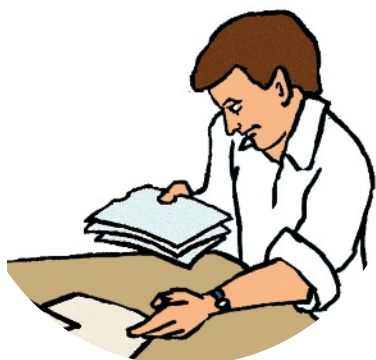

Please tell us:

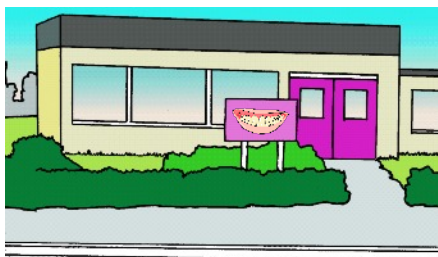
- your name, address



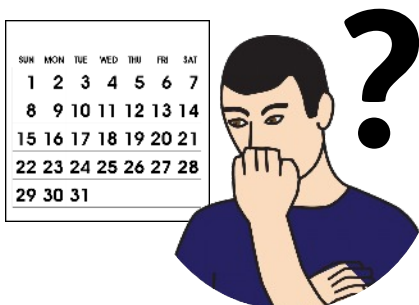
- the best way to get in touch with you



- if you need information in any special way



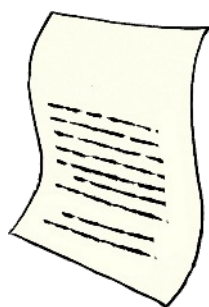
- the full name and address of the person or company you are worried about (if you know it)



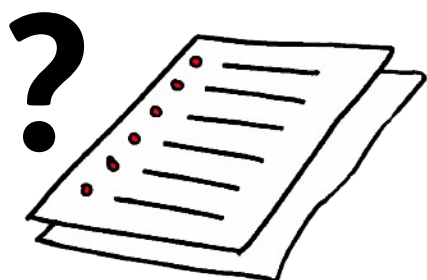
- details about your worry, like what happened and when
